

ORDINANCE 14-O-45 amending the Murfreesboro City Code, Chapter 2, Article V and Sections 21-49 and 21½-15, regarding the golf commission and City golf courses.

WHEREAS, the provisions of the Murfreesboro City Code were adopted when the City was in the process of creating the Old Fort Golf Course and should now be updated; and,

WHEREAS, the City of Murfreesboro now owns and operates two golf courses, Old Fort Golf Course and Bloomfield Links, and leases and operates the VA Golf Course.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MURFREESBORO, TENNESSEE, AS FOLLOWS:

SECTION 1. Chapter 2, Article V of the Murfreesboro City Code dealing with the Murfreesboro Golf Commission is hereby amended by deleting it in its entirety and substituting in lieu thereof the following:

ARTICLE V. MURFREESBORO GOLF COMMISSION

SECTION 2-91 MURFREESBORO GOLF COMMISSION CREATED.

The City golf commission created in 1983 shall be known as the "Murfreesboro Golf Commission."

SECTION 2-92 COMPOSITION; MEMBER TERM OF OFFICE; COMPENSATION.

(A) *Composition; member term of office.* The Murfreesboro Golf Commission shall consist of seven (7) members, one of whom shall be a City Council member. The remaining six (6) members shall be qualified voters of the City. A member of the Parks and Recreation Commission shall serve as an ex-officio member. All members of the Commission shall be appointed by the Mayor with the consent of the Council. Each term of a Murfreesboro Golf Commission member shall be for three years, staggered. The term of the Council member shall be coterminous with the member's council term of office.

(B) *Compensation.* All members of the Commission shall serve as such without compensation unless and until the Council shall fix and provide for such compensation.

SECTION 2-93 ORGANIZATION; CHAIR TERM OF OFFICE; MEETINGS; RULES AND RECORDS.

The Murfreesboro Golf Commission shall elect its chair from among its membership and create and fill such other of its offices as it may determine. The term of the Commission chair shall be for one year with eligibility for reelection. The Commission shall hold at least one regular meeting each quarter. Such meetings shall be open to the public. The

Commission may adopt rules for transaction of business and shall keep minutes of its meetings.

SECTION 2-96 PURPOSES.

The purposes of the Murfreesboro Golf Commission are as follows:

- (A) to assist in identifying sources of funds and in the securement of funds for the construction and maintenance of golf courses and facilities;
- (B) to recommend the selection and employment of engineers, architects, landscape architects and other consultants;
- (C) to review and recommend plans, methods and contracts for construction for golf courses and related facilities;
- (D) to study and recommend land for acquisition for golf courses and facilities;
- (E) to establish fees and charges, and golf course rules, regulations and guidelines, for play and conduct on the City's golf courses by participants and other members of the public;
- (F) to oversee the operations of the Golf Department in order to assure quality golf courses which meet the needs and protect the interests of the public; and,
- (G) to annually recommend a budget for the Golf Department to the City Council.

SECTIONS 2-97–2-109 RESERVED.

SECTION 2. Section 21-49 of the Murfreesboro City Code is hereby amended by deleting it in its entirety and substituting in lieu thereof the following:

SECTION 21-49 TRESPASSING ON GOLF COURSES; PENALTY.

- (A) The purpose of any City owned or operated golf course is golfing. Authorized golfers, those accompanying authorized golfers within guidelines established by the Murfreesboro Golf Commission, and City officials, employees and contractors on official business may be present on a City golf course. During golf tournaments, the general public may be present on a City golf course in areas designated for the gallery upon conditions established by the Murfreesboro Golf Commission. All others will be trespassers.
- (B) Any person violating this section shall be punished as provided in Code §1- 8.



SECTION 3. Section 21½ -15 of the Murfreesboro City Code is hereby amended by deleting the reference to "Old Fort Golf Commission" and substituting in lieu thereof "Murfreesboro Golf Commission.

SECTION 4. That this Ordinance shall take effect fifteen (15) days after its passage upon third and final reading, the public welfare and the welfare of the City requiring it.




