

RESOLUTION 17-R-27 to approve Kentucky Educational Development Corporation as a purchasing cooperative under the City's Procurement Code.

WHEREAS, the City of Murfreesboro has adopted a procurement code, Ordinances 13-O-38 and 14-O-55, adopting the provisions of State law (T.C.A. §12-3-1205) allowing the City to enter into agreements with other governmental entities for the joint exercise of purchasing authority as a means of meeting competitive bidding requirements; and,

WHEREAS, the Kentucky Educational Development Corporation ("KEDC"), 904 Rose Road, Ashland, KY 41102-7104 is an educational cooperative organized under the Interlocal Cooperation Act and providing various services to its member school districts. KEDC also acts as fiscal agent for all KPC members including the following similarly organized Kentucky education cooperatives that offer bidding services: Green River Regional Education Cooperative (GRREC), Northern Kentucky Cooperative for Educational Services (NKCES), Ohio Valley Educational Cooperative (OVEC), Southeast/South-Central Educational Cooperative (SESC), and West Kentucky Educational Cooperative (WKEC); and,

WHEREAS, the City wishes to make procurements through KEDC and,


WHEREAS, pursuant to T.C.A. §12-3-1205 (b)(2) a municipality may participate in a cooperative purchasing agreement by adopting a resolution accepting the terms of the master agreement and the KEDC master agreement is attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MURFREESBORO, TENNESSEE, AS FOLLOWS:




SECTION 2. This Resolution shall be effective immediately upon its passage and adoption, the public welfare and the welfare of the City requiring it.
