Murfreesboro 2035 Community Meeting, Tues. Oct. 27

The City of Murfreesboro wants to hear from citizens as part of the process to develop its 20-year comprehensive plan. A Community Meeting is scheduled at Patterson Park Community Center to gather citizen input on the City's Future Land Use and Character Plan, draft Chapter 4. Who: The Citizens of Murfreesboro and anyone interested in planning for the City's future over the next 20 years.

What: Citizens are encouraged to gather to hear a presentation from consultant Kendig Keast Collaborative (KKC) and provide input on draft Chapter 4, *Land Use & Character*, as it relates to Murfreesboro's quality of life, community character, and growth capacity. The Community Meeting is part of the 2-year process of developing a comprehensive plan for the City of Murfreesboro called ***Murfreesboro 2035: Our Future Begins Now.***

KCC will also provide an update on the *Murfreesboro 2035 Plan* to the **City Council**, Thurs. Oct. 29, 2015, from 5:30 p.m. – 6:30 p.m., prior to the Council's regularly scheduled meeting.
