

**RESOLUTION 16-R-09** approving Chapter 31 of the Private Acts of 2016.

**WHEREAS**, the Murfreesboro City Council unanimously asked the Tennessee General Assembly to amend the City Charter in Resolution 15-R-09 on April 2, 2015; and,

**WHEREAS**, the Tennessee General Assembly granted said request and passed House Bill 1858 as Private Chapter 31 of the Private Acts of 2016; and,

**WHEREAS**, said Private Act provides that it is of no effect unless it is approved by a two-thirds (2/3rds) vote of the City Council; and,

**WHEREAS**, there is good reason to make the changes to the City Charter which will be made by approving Chapter 31 of the Private Acts of 2016.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MURFREESBORO, TENNESSEE, AS FOLLOWS:**

SECTION 1. Chapter 31 of the Private Acts of 2016, attached, is hereby approved.

SECTION 2. The Mayor, as the presiding officer of the City Council, is authorized and directed to proclaim and certify said approval to the Tennessee Secretary of State.


SECTION 3. This Resolution shall be effective immediately upon its passage and adoption, the public welfare and the welfare of the City requiring it.



**PRIVATE CHAPTER NO. 31**

**HOUSE BILL NO. 1858**

AN ACT to amend Chapter 429 of the Private Acts of 1931; as amended by Chapter 526 of the Private Acts of 1933; Chapter 109 of the Private Acts of 1991; Chapter 104 of the Private Acts of 1993; and any other acts amendatory thereto, relative to the charter of the City of Murfreesboro.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 429 of the Private Acts of 1931, as amended by Chapter 526 of the Private Acts of 1933, Chapter 109 of the Private Acts of 1991, Chapter 104 of the Private Acts of 1993, and any other acts amendatory thereto, is amended in Article V, Section 24, by deleting subsection (a) and substituting instead the following:

(a) Every ordinance shall be in writing when considered for adoption by the City Council. Adoption of an ordinance requires passage by a majority vote of the City Council on two (2) different days with at least one (1) week between the first and second votes.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of the City of Murfreesboro. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2.


